These prices are effective December 1, 2022, but are subject to change without notice.

We offer the following goods and services. You may choose only those items you desire. However, any arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods you selected.

Pre-need Arrangements – “Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the deceased and is in the possession of the funeral establishment.”

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers.

Services Available:

Our charge for cremation (without ceremony) includes: transportation staff and transportation of remains up to 20 miles 24 hours a day (worldwide transportation coverage included if passing occurs greater than 75 miles from residence), pacemaker/electronic device removal, document preparation services, notification of death to Social Security, standard refrigeration, standard cremation (**7 business days**) up to 250 pounds (251-400 pounds, additional \$390.00 plus cost of wood framed container \$195.00). Includes - DCA fee (\$8.50), disposition permit (\$12.00), Death Certificate processing (Certified copies are an added at \$24.00 each), cremation container, plastic urn, and sales tax. **\$1,499.00**

Additional Fees As Needed:

- An additional \$100.00 transportation charge will apply from 5pm-8am and on holidays.
- An additional staff fee of \$100.00 will apply when transferring from a residence or nursing facility.
- An additional fee of \$5.00 per mile after 20 miles.
- A charge of \$25 per day will apply if completed documents and payment are not received within 3 days of bringing your loved one into our care.
- An additional fee of \$75.00 will apply for Removal of Pacemaker or other electronic device (per device)
- Los Angeles County Coroner Sign Out Fee \$48.00 + Processing Fee \$25.00
- Los Angeles County Coroner Drop Off/Pickup Fee \$350.00
- Inurnment in acceptable urn provided by family (per urn) \$35.00
- Shipment/Delivery of cremated remains via US Postal Service (within 50 United States) \$225.00
